

Call for Papers for a Special Issue on Quantitative Analysis of Energy Markets

The journal *Energy Economics* will publish a Special Issue on **Quantitative Analysis of Energy Markets**. This is the main topic of the 2010 International Workshop on Quantitative Analysis of Energy Markets (QAoEM 2010) that has taken place at the University of Verona (Italy) on September 13-14, 2010. This Special Issue of **Energy Economics** is designed to collect a range of high quality research papers from the field of **Statistical, Mathematical and Econometric methods for data related to Energy Markets**. Topics of particular interest may include, but are not limited to:

- electricity market modeling and simulation,
- impact of new technologies,
- cross-border issues,
- CO2 emissions trading,
- green certificate markets,
- risk management,
- futures, forwards and derivatives,
- price and volatility dynamics,

Researchers and practitioners are kindly requested to submit relevant and innovative papers for publication in this Special Issue. Papers should be written following the instructions given in the Journal website (<http://ees.elsevier.com/eneeco/>).

Submitted papers must contain original unpublished work that has not been submitted for publication elsewhere. All manuscripts submitted to this Special Issue will undergo the classical double-blind reviewing process.
